Letter from Public Health Administrator

The 2020 year in review, Global Coronavirus (COVID-19) Pandemic! After many years of public health emergency preparedness, planning, tabletop, functional, and full- scale exercises, our hard work and efforts paid off in responding to the COVID-19 pandemic. In March of this year the first case of COVID-19 was identified in Milwaukee County and from that time on the United States, Wisconsin, Milwaukee County, South Milwaukee, and St. Francis declared a State of Emergency. This State of Emergency continued through 2020.

Milwaukee County Office of Emergency Management stood up a Unified Emergency Operations Center (UEOC) and our communities were well represented in key roles of Public Health in Operations, Planning Section Chief, and Duty Officer, Safety and Risk, Emergency Medical Services, Law Enforcement, Local Emergency Operations Centers, UEOC Sponsorship, and in workgroups and committees. This joint effort brought together many partners across multiple sectors of government, healthcare, non- profits, businesses, educational institutions, and more to have a unified response to COVID-19.

This response from case investigation, isolation and quarantine, public health orders and guidance, testing initiatives, vaccination initiatives, and community education was made possible by the incredible efforts of the health department team supported by all of the municipal departments in South Milwaukee and St. Francis, and volunteers. For all of these incredible partnerships we are extremely grateful.

Many of our programs and services were impacted by the pandemic.

We look forward to lessons learned and moving beyond the COVID-19 pandemic in 2021.

In addition to the above services, the Environmental Health Consortium coordinated beach testing at Grant and Bayview Park Beaches, assisted with COVID-19 response with licensed establishments with order enforcement, and education for safe re-opening.

Coronavirus (COVID-19) Response

The health department team conducted disease investigation and contact tracing, issued isolation and quarantine orders to assure compliance, issued orders of closure, and guidance for operating and safe re-opening. The public health team provided community education, testing and vaccinations in conjunction with the other south shore health departments of Cudahy and Oak Creek. As we have planned in the past as a zone for emergency preparedness and response, we put those plans into action!

TRICK OR TREATERS

- REMAIN 6 FEET APART FROM PEOPLE NOT IN YOUR HOUSEHOLD
- WEAR A FACE MASK COVERING BOTH YOUR MOUTH AND NOSE EVEN UNDER/OVER YOUR HALLOWEEN MASK
- HAND SANITIZE (WITH SANITIZER CONTAINING AT LEAST 60% ALCOHOL) FREQUENTLY WHEN OUT, ESPECIALLY AT KEY TIMES LIKE BEFORE EATING OR AFTER COUGHING/SNEEZING

HOME OWNERS

- DON'T HAND OUT CANDY IF YOU ARE SICK
- WEAR A FACE MASK COVERING BOTH YOUR MOUTH AND NOSE
- USE TAPE TO MARK X'S THAT ARE 6 FOOT APART FROM THE DRIVEWAY UP TO DOORWAY
- POSITION A DISTRIBUTION TABLE BETWEEN YOURSELF AND THE TRICK-OR-TREATERS. PLACE CANDY ON TABLE AND DISINFECT BETWEEN TRICK-OR-TREATERS
- WASH HANDS OR SANITIZE FREQUENTLY BETWEEN TRICK-OR-TREATERS

- INSPECT ALL CANDY


