

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 05/21/18 – 05/28/18



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

Last week the South Milwaukee Police Department responded to **337** calls for service.

HIT AND RUN ACCIDENT

A 53 year old South Milwaukee woman was issued citations for Hit and Run and Obstructing after witnesses stated a white vehicle struck a pick-up truck in the 2400 Block of 6th Avenue at 5:30 pm on May 26th. The witnesses also stated the vehicle fled the scene with two flat tires and the engine smoking. Officers followed a fluid trail to a closed garage in the 2800 Block of 5th Avenue where citations were issued.

DISORDERLY CONDUCT

A 29 year old Milwaukee woman was issued a citation for Disorderly Conduct in the 1900 Block of 17th Avenue around 9:50 pm on May 26th after officers were dispatched to a report of a group of people arguing with a cab driver over fare. The fare was paid and the argument was resolved however the woman continued to yell loudly and after being told to leave the area, went into a nearby tavern and threw two bar stools to the ground.

A 52 year old South Milwaukee woman was issued a citation for Disorderly Conduct and Battery in the 1400 Block of Missouri Avenue around 9:30 pm on May 28th after she reportedly threw a plastic chair off her porch at a neighbor, causing a minor injury. The woman, who was intoxicated, continued to shout at officers out an open window but refused to answer the door and was issued citations.

A 37 year old South Milwaukee woman will be issued citations for Dog at Large after her dog escaped and attacked another dog at 1:00 pm in the 400 Block of Marion Avenue on May 23rd and again around 7:30 pm on May 24th in the 400 Block of Menomonee Avenue.

A 31 year old South Milwaukee woman was issued a citation for Dog at Large at 6:45 am on the bike trail near 17th and Marquette Avenues on May 25th after her dog ran into a 32 year old South Milwaukee man on his bike causing him to crash.
