

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 06/11/18 – 06/17/18



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

Last week the South Milwaukee Police Department responded to **424** calls for service.

RETAIL THEFT

Officers were dispatched around 8:10 pm on June 15th to a report of two men leaving WalMart in the 200 Block of North Chicago Avenue without paying for window air conditioning units. The men had left the area prior to the arrival of officers. On June 16th at 6:50 pm the same men were reported to have returned to WalMart attempting to take more air conditioning units. Officers arrested a 58 year old Milwaukee man and a 63 year old Milwaukee man for retail theft and both admitted to taking merchandise during each incident. The 63 year old man was issued a citation for Trespassing as he was previously banned from the store due to prior retail thefts. Both men were referred to the Milwaukee County District Attorney's Office Community Prosecutor program.

DISORDERLY CONDUCT

A 30 year old South Milwaukee man was located with a head injury in the 1100 Block of Milwaukee Avenue around 10:20 pm on June 12th after officers were dispatched to a report of three males chasing another male. The 30 year old man reported being struck in the head with an unidentified object by an unknown subject and was transported to the hospital by a South Milwaukee Fire Department ambulance. The investigation is pending the identification of the suspect.

CRIMINAL DAMAGE

A 32 year old South Milwaukee woman reported the front windows to a residence in the 1200 Block of Minnesota Avenue being damaged by a brick at 4:30 am on June 13th. A neighbor reported a possible suspect leaving the area on foot through a nearby alley.

OPERATING WHILE INTOXICATED

A 43 year old Racine man was referred to the Milwaukee County District Attorney's Office for charges of Operating While Intoxicated-2nd Offense after a citizen reported following a vehicle that was driving slowly and randomly stopping in the lane of traffic at Nicholson and Rawson Avenues at 2:30 am on June 16th. The citizen also reported the vehicle was swerving and failed to stop at a flashing red traffic signal before officers were able to pull the vehicle over in the 1100 Block of Rawson Avenue.

A 41 year old South Milwaukee man was referred to the Milwaukee County District Attorney's Office for charges of Operating While Intoxicated-4th Offense after Officers observed a vehicle fail to stop at a stop sign at 6th and Milwaukee Avenues and conducted a traffic stop in the 700 Block of Hawthorne Avenue at 2:00 am on June 16th.

A 46 year old Milwaukee woman was referred to the Milwaukee County District Attorney's Office for charges of Operating While Intoxicated-4th Offense after her vehicle struck another vehicle in the WalMart parking lot in the 200 Block of North Chicago Avenue just after 7:00 pm on June 12th.
