

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 06/04/18 – 06/10/18



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

Last week the South Milwaukee Police Department responded to **307** calls for service.

WEAPONS VIOLATION

A 20 year old South Milwaukee man was referred to the Milwaukee County District Attorney's Office for possible Recklessly Endangering Safety charges after a 25 year old Oak Creek man and a 23 year old Milwaukee woman reported the driver of a silver vehicle pointed a gun at them around 7:00 pm on June 9th at 15th and Michigan Avenues. The callers provided officers with a license plate of the vehicle which was located at a residence in the 1400 block of Menomonee Avenue where the South Milwaukee man was taken into custody after the weapon, an unloaded airsoft pistol, was found.

DISORDERLY CONDUCT

A 61 year old South Milwaukee man was issued a citation for battery and a 57 year old South Milwaukee woman was cited for Disorderly Conduct after officers were dispatched for a second time to a report of a loud argument in the 3400 block of Marina Road at 6:20 pm on June 4th. The investigation revealed the 61 year old man reportedly struck the 57 year old female after she intentionally spilled his bottle of alcohol.

A 26 year old South Milwaukee woman was referred to the Milwaukee County District Attorney's Office for possible Disorderly Conduct While Armed charges after officers were dispatched to a report of a male and female arguing in the 400 block of Marion Avenue around 12:40 pm on June 8th. The investigation revealed the South Milwaukee woman threw a hammer at a 23 year old Milwaukee man which broke a glass door.

HIT AND RUN ACCIDENT

A 23 year old South Milwaukee man reported his 2010 Kia was struck while parked in the 3200 Block of South Chicago Avenue at 8:30 am on June 4th. Using parts left at the scene, officers were able to locate the striking vehicle, a Nissan, in the 3300 Block of Marina Road and the vehicle's owner, a 35 year old Horicon man, was cited for Hit and Run to an Unattended Vehicle.

WARRANT ARREST

A 33 year old South Milwaukee man was arrested on a valid Probation and Parole warrant after officers were dispatched to a welfare check on a male sitting on the curb with his feet in traffic at Nicholson and College Avenues around 6:00 pm on June 8th.

A 23 year old South Milwaukee man was arrested on a valid warrant with the Racine County Sheriff's Department after officers were dispatched to a report of an intoxicated male bumping into cars and walking through yards in the 600 Block of Madison Avenue at 10:00 pm on June 5th.

A 28 year old South Milwaukee woman was arrested on a valid warrant with the Milwaukee County Sheriff's Department and was issued a citation for Obstructing after officers conducted a traffic stop on a vehicle without license plates at 4:50 pm on June 8th in the 600 Block of Michigan Avenue. The woman, who was driving, initially refused to identify herself but was later identified by other officers through prior police contacts.

A 38 year old South Milwaukee woman was arrested on a valid warrant with the Milwaukee County Sheriff's Department at 2:15 am on June 9th after officers were dispatched to a report of an intoxicated female walking barefoot in the roadway at Nicholson and Milwaukee Avenues.
