

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY 08/13/18 – 08/19/18**



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

Last week the South Milwaukee Police Department responded to **307** calls for service.

### **ARMED ROBBERY**

At 7:39 pm on August 18<sup>th</sup>, a 14 year old South Milwaukee boy and a 14 year old Cudahy boy reported being confronted by a group of individuals who robbed them of a cellphone, phone chargers, and other personal property at gunpoint while walking along railroad tracks behind WalMart in the 200 Block of North Chicago Avenue. Some of the suspects were acquaintances of the victims. Through an investigation, officers identified and arrested four individuals, a 17 year old South Milwaukee boy, a 16 year old South Milwaukee boy, a 17 year old Franklin boy, and a 15 year old Milwaukee girl who all admitted involvement. The weapon used was reported to be a BB gun and all four individuals will be referred to the Milwaukee County District Attorney's Office for charges.

### **DISORDERLY CONDUCT**

A 31 year old South Milwaukee man and a 30 year old South Milwaukee man were issued citations for Disorderly Conduct after officers received a report of two men fighting in the roadway at 15<sup>th</sup> and Rawson Avenues at 2:00 am on August 19<sup>th</sup>. The men, who were intoxicated, had gotten into an argument at a nearby tavern and were yelling at each other upon officer's arrival. They were taken to the Police station and issued citations before being released.

**A 46 year old Cudahy woman reported being struck in the face by a 40 year old Cudahy woman in the 2300 Block of 12<sup>th</sup> Avenue just after 10:00 pm on August 18<sup>th</sup>. The 40 year old woman left the scene prior to officer's arrival and witnesses stated both women became involved in an argument as they left a nearby tavern. Both women will be issued citations for Disorderly Conduct.**

**A 23 year old West Milwaukee man was issued a citation for Disorderly Conduct in the 1300 Block of Milwaukee Avenue at 7:30 pm on August 19<sup>th</sup> after officers responded to a report of a subject passed out with a bottle of alcohol. When officers woke the man he began to argue with them and yell loudly. When the man refused to stop shouting he was arrested and issued a citation for Disorderly Conduct.**

### **WARRANT ARREST**

**A 31 year old South Milwaukee woman was arrested on valid Milwaukee County Sheriff's Department felony warrants for Fleeing and First Degree Endangering Safety around 10:20 pm in the 1200 Block of Minnesota Avenue on August 17<sup>th</sup>. The woman was brought to the Police station and turned over to Milwaukee County Sheriff's Department deputies.**

### **RETAIL THEFT**

**A 22 year old Franklin man was issued a citation for Retail Theft after he left Pick N Save in the 2900 Block of South Chicago Avenue without paying for energy drinks at 1:30 pm on August 18<sup>th</sup>. Officers located the man in front of a nearby business drinking one of the drinks and he was arrested, cited, and released.**
