

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 1/14/19 – 1/20/19



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **211** calls for service.

BATTERY

Officers were dispatched to a report of a woman being punched in the face in the 1200 Block of Memorial Drive at 10:13 pm on January 17th. The victim, a 34 year old South Milwaukee woman stated she was struck by a 30 year old Oak Creek woman after the woman refused to leave her residence. The Oak Creek woman was arrested and taken to the police station where she was issued a citation for Battery and released.

DISORDERLY CONDUCT

A 62 year old South Milwaukee woman was issued a citation for Disorderly Conduct in the 600 Block of Columbia Avenue at 9:00 pm on January 14th after neighbors reported to police she kicked at their dog and threatened them with mace. The woman was loud and argumentative while speaking with officers and she was issued the Disorderly Conduct citation.

A 31 year old Milwaukee woman was issued citations for Disorderly Conduct, Battery, and Criminal Damage to Property in the 500 Block of Lakeview Avenue at 10:21 pm on January 17th. An investigation revealed that when the woman was asked to leave the residence of a 28 year old South Milwaukee man, she struck him, broke a window, and damaged a door. She was taken to the police station and issued the citations before being released.

RESTRAINING ORDER VIOLATION

Officers were dispatched to a report of an individual at a residence in the 600 Block of Montana Avenue in violation of a court-ordered no contact order just after 5:00 pm on January 19th. Officers located a 28 year old South Milwaukee man on the scene who came to the residence uninvited. Dispatch verified the existence of the no contact order as a condition of the man's bail from a Milwaukee County case and the man was arrested. Upon searching the man, a capped needle was located. He was taken to the police station and issued a citation for Possession of Drug Paraphernalia. He was transported to the Milwaukee County Criminal Justice Facility and was later charged by the Milwaukee County District Attorney's Office with one count of misdemeanor Bail Jumping.

OPERATING WHILE INTOXICATED

A resident in the 1600 Block of Monroe Avenue reported having a confrontation with an individual who parked his truck on the grass and blocked the resident's driveway at 7:23 pm on January 17th. The resident reported the driver of the truck argued with him and went into a nearby business. Officers located the driver of the truck, a 28 year old Oak Creek man, and upon speaking with him noticed signs of impairment. The Oak Creek man was arrested and taken to the police station where he was issued citations for Operating While Intoxicated-First Offense and Prohibited Blood Alcohol Concentration before being released to a sober adult.
