# SOUTH MILWAUKEE POLICE DEPARTMENT WEEKLY CRIME SUMMARY 1/3/18 – 1/13/19

(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past 10 days the South Milwaukee Police Department responded to 365 calls for service.

# **HOMICIDE**

At approximately 9:30 am on January 11<sup>th</sup>, the South Milwaukee Police and Fire Departments responded to an apartment building in the 500 block of Clark Avenue for a report of a stabbing. Upon arrival, officers found a 62-year-old female with multiple stab wounds. Despite lifesaving efforts, she was pronounced deceased. A 31-year-old male acquaintance of the victim, was taken into custody and charged by the Milwaukee County District Attorney's Office with First Degree Intentional Homicide-Use of a Dangerous Weapon.

# **DISORDERLY CONDUCT**

A 36 year old Cudahy man was issued a citation for Disorderly Conduct in the 1200 Block of Columbia Avenue just before Noon on January 3<sup>rd</sup> after officers were dispatched to a welfare check. A caller stated while attempting to contact a female at a residence in the area by phone, he heard a commotion which led him to believe she was in danger. Officers arrived at the residence and after several minutes, located the female unharmed with the Cudahy man and another female. It was determined the Cudahy man fabricated the circumstances that led the caller to believe an emergency was taking place in order to get the caller to stop calling. The Cudahy man was taken to the police station where he was issued the Disorderly Conduct citation.

A 64 year old South Milwaukee man was issued a citation for Lewd and Lascivious Behavior in the 2300 Block of 17<sup>th</sup> Avenue at 11:20 am on January 5<sup>th</sup> after a citizen reported a man standing nude in the area. Upon arrival, an officer observed the man sitting outside nude before entering a nearby residence. He was taken to the police station where he was issued the citation.

#### **ENDANGERING SAFETY**

Officers were dispatched to a report of a man passed out in a vehicle in the parking lot of a business in the 2700 Block of South Chicago Avenue at 5:43 am on January 11<sup>th</sup>. Officers located a 28 year old Milwaukee man in the driver's seat of the parked vehicle leaning forward with his head on the steering wheel. The man showed signs of impairment and upon searching the vehicle, a loaded handgun was located in the vehicle's center area. The man did not have a Concealed Carry permit. He was arrested and referred to the Milwaukee County District Attorney's Office on charges of Endangering Safety by Use of a Dangerous Weapon While Intoxicated and a Concealed Carry Violation.

### **OPERATING WHILE INTOXICATED**

Officers were dispatched to a report of a female passed out in a vehicle in the parking lot of a business in the 200 Block of North Chicago just after 9:00 pm on January 9<sup>th</sup>. Upon arrival, officers located a 35 year old Milwaukee woman sleeping behind the wheel with the engine running. Upon awakening she showed signs of impairment and was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Operating While Intoxicated-2<sup>nd</sup> Offense.
