

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY 12/25/18 – 1/2/19**

The past week the South Milwaukee Police Department responded to **271** calls for service.

### **DISORDERLY CONDUCT**

A 50 year old South Milwaukee man was issued citations for Trespassing and Disorderly Conduct after officers were dispatched to a report of person causing problems and refusing to leave the a business in the 1100 Block of Marquette Avenue at 5:07 pm on January 1<sup>st</sup>. The man was issued the citations after putting inappropriate signs in the windows of the business.

A 62 year old South Milwaukee man was issued a citation for Disorderly Conduct after officers were dispatched to a report of a man who was intoxicated and yelling at family members in the 1000 Block of Davis Avenue on December 27<sup>th</sup>. Officers were originally dispatched to the residence at 9:57 pm and advised the man to not bother the other individuals. Officers were then dispatched to the residence again at 10:59 pm as the man was continuing to cause problems. He was then arrested and taken to the police station where he was issued the citation.

A 51 year old South Milwaukee woman was issued citations for Unnecessary Noise and Disorderly Conduct in the 2000 Block of 10<sup>th</sup> Avenue on December 29<sup>th</sup> after officers were dispatched to a report of a person yelling and swearing loudly at 6:40 pm. Officers made contact with the woman who was uncooperative and advised her she would be receiving a citation for the noise. Officers were then dispatched back to the residence at 7:08 pm for a report that the woman was pounding on the walls while continuing to swear loudly and a disorderly conduct citation was issued.

## **DRUG INVESTIGATION**

A 40 year old South Milwaukee man will be charged at the Milwaukee County District Attorney's Office with Possession with Intent-THC, Manufacturing THC, and Felony Bail Jumping after officers uncovered a marijuana grow operation following a search warrant in the 2900 Block of South Chicago Avenue at 4:42 pm on December 30<sup>th</sup>.

## **WARRANT ARREST**

A 40 year old South Milwaukee man was arrested on confirmed warrants with the Milwaukee County Sheriff's Office and the West Bend Police Department at 12:04 pm on December 28<sup>th</sup> after officers were dispatched to a report of a vehicle swerving in the roadway near 9<sup>th</sup> and Monroe Avenues. The caller also reported the other driver threatened him. Officers located the vehicle parked in the 200 Block of North Chicago and the driver was located in a nearby store. He was taken into custody on the warrants and turned over to deputies from the Milwaukee County Sheriff's Office.

## **VEHICLE THEFT**

A resident in the 500 Block of North Chicago Avenue reported his 2018 GMC Sierra Pick-Up Truck taken from his driveway sometime between 2:00 am and 9:00 am on December 30<sup>th</sup>. The vehicle is brown in color and has two stickers on the rear window as well as a scrape on the passenger side rear wheel well and a dent on the passenger side rear bumper.
