

# **SOUTH MILWAUKEE POLICE DEPARTMENT**

## **WEEKLY CRIME SUMMARY 1/28/19 – 2/03/19**

The past week the South Milwaukee Police Department responded to **271** calls for service.

### **RECOVERED STOLEN VEHICLE**

Officers responded to a two vehicle crash at 15<sup>th</sup> and Rawson Avenues at 10:39 am on February 3<sup>rd</sup>. One of the vehicles involved was reported stolen from the city of Milwaukee and the occupants of the stolen vehicle fled the scene. With the valuable assistance of the residents of the neighborhood, officers were able to arrest four juveniles from the city of Milwaukee in connection with this incident.

### **OPERATING WHILE INTOXICATED**

An officer observed a vehicle fail to stop at a stop sign at 6<sup>th</sup> and Milwaukee Avenues at 2:21 am on February 2<sup>nd</sup> and conducted a traffic stop in the 2000 Block of 9<sup>th</sup> Avenue. The driver, a 48 year old South Milwaukee woman, showed signs of impairment. She was arrested and taken to the police station where she was issued citations for Operating While Intoxicated-2<sup>nd</sup> Offense, Prohibited Blood Alcohol Concentration and Failure to Stop at a Stop Sign before being transported to the Milwaukee County Criminal Justice Facility.

**An officer observed a vehicle fail to stop at flashing red lights at North Chicago and College Avenues at 3:26 am on February 3<sup>rd</sup> and conducted a traffic stop and conducted a traffic stop in the 4600 Block of South Packard Avenue in Cudahy. The driver, a 34 year old Milwaukee man, showed signs of impairment. He was arrested and taken to the police station where he was issued citations for Operating While Intoxicated-First Offense and Prohibited Blood Alcohol Concentration before being released to a sober adult.**

**An officer observed a vehicle fail to stop at a stop sign turning onto Marquette Avenue from South Chicago Avenue at 10:35 pm on February 1<sup>st</sup> and conducted a traffic stop near 10<sup>th</sup> and Michigan Avenues. The driver, a 46 year old St. Francis man, showed signs of impairment. He was arrested and brought to the police station where he was issued citations for Operating While Intoxicated-First Offense and Prohibited Blood Alcohol Concentration.**

### **RETAIL THEFT**

**Officers were dispatched to a report of an individual leaving a store in the 2900 Block of South Chicago Avenue without paying for two bottles of liquor. The suspect, a 31 year old Milwaukee man, returned to the business and was detained by officers. The liquor bottles were located hidden inside a neighboring business. The Milwaukee man was arrested and taken to the police station where he was issued a citation for Retail Theft.**
