

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 2/18/19 – 2/24/19



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **278** calls for service.

VEHICLE THEFT

A resident in the 1000 Block of Davis Avenue reported her vehicle and credit card missing at 9:23 am on February 20th. The vehicle was located in the city of Milwaukee on February 21st and later that day, a 40 year old South Milwaukee man and a 32 year old South Milwaukee woman were arrested. Both were taken to the Milwaukee County Criminal Justice Facility and charges of Operating a Motor Vehicle Without Owner's Consent and Unauthorized Use of a Personal Identifying Document were referred to the Milwaukee County District Attorney's Office. The credit card was also returned to the original caller.

DRUG INVESTIGATION

Officers and South Milwaukee Fire Department personnel were dispatched to a report of a possible drug overdose in the 100 Block of Brookdale Drive at 9:17 pm on February 18th. A 39 year old South Milwaukee man was found unconscious with drug paraphernalia in the residence. South Milwaukee Fire Department personnel revived the man and he was taken to the hospital. The man was issued a citation for Possession of Drug Paraphernalia.

DISORDERLY CONDUCT

Officers were dispatched to a report of two females fighting in the 500 Block of Southtowne Drive at 4:08 pm on February 23rd. Upon arrival, officers located two 30 year old South Milwaukee women who stated they had a verbal argument but were not fighting. One of the women was found to have three confirmed warrants with the Germantown Police Department. She was arrested on the warrants and taken to the police station where she was turned over to officers from the Germantown Police Department.

Officers were dispatched to the 3300 Block of Marina Road at 11:17 pm on February 19th for a report of an intoxicated individual at the wrong apartment. Officers located a highly intoxicated 58 year old South Milwaukee woman who argued with officers and initially refused to go to her correct apartment. She was eventually assisted to her apartment by officers and issued a citation for Disorderly Conduct.

THEFT

Officers conducted a traffic stop on a vehicle that was observed near the Self Deposit Station in the 1100 Block of Blake Avenue with its lights off at 1:50 am on February 23rd. The driver, a 35 year old Milwaukee woman, was issued a citation for Operating After Revocation and the passenger, a 28 year old South Milwaukee man was arrested on a confirmed South Milwaukee Police Department warrant. Upon searching the vehicle, computers and copper wires and tubes were located along with evidence that the items were taken from the Self Deposit Station. The man admitted to climbing the fence and taking the items from the Self Deposit Station. He was referred to the Milwaukee County District Attorney Community Prosecutor on charges of Criminal Damage to Property, Theft, and Trespassing. The Milwaukee woman was also referred on Party to a Crime charges.
