

# ***SOUTH MILWAUKEE POLICE DEPARTMENT***

## ***WEEKLY CRIME SUMMARY 4/21/19 – 4/28/19***



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **250** calls for service.

### **DISORDERLY CONDUCT**

Officers were dispatched to a report of a male fighting with a female in the 2800 Block of 6<sup>th</sup> Avenue on April 24<sup>th</sup>. Prior to arrival, the male party fled the scene in the female's vehicle. Officers located the vehicle and conducted a traffic stop in the 1300 Block of Milwaukee Avenue. The driver, a 28 year old South Milwaukee man, was determined to be the involved party in this incident. He was arrested and charged by the Milwaukee County District Attorney's Office with Disorderly Conduct/Domestic Violence, Criminal Damage to Property, Intimidation of Victims, and Operating After Revocation.

Officers were dispatched to a report of subjects arguing in the 1200 Block of Milwaukee Avenue on April 23<sup>rd</sup>. Upon arrival officers located a 53 year old South Milwaukee man and a 44 year old South Milwaukee woman shouting at each other outside. There was a restraining order in place against the woman and she was arrested. She was taken to the police station and referred to the Milwaukee County District Attorney's Office on the restraining order violation. She was also issued a citation for Resisting/Obstructing.

## **BATTERY**

Officers were dispatched to a report of an unwanted person at a residence in the 1600 Block of Monroe Avenue on April 26<sup>th</sup>. Upon arrival, officers spoke with a 30 year old South Milwaukee woman and a 29 year old South Milwaukee man. The man claimed he was punched in the mouth by the woman and had visible injuries. He denied medical attention and the woman was issued a citation for Battery.

## **VEHICLE THEFT**

A 21 year old South Milwaukee man reported his white 2014 Chrysler 300 stolen from the 500 Block of Southtowne drive on April 23<sup>rd</sup>. The man stated he parked the car in an assigned spot the night before and noticed it gone the following evening. ## **RETAIL THEFT**

Officers were dispatched to a report of a female who concealed items inside a business in the 2900 Block of South Chicago Avenue and left without paying for them on April 23<sup>rd</sup>. Officers located a 60 year old Milwaukee woman nearby and she was arrested and issued a citation for Retail Theft after she was identified as the woman in the store.

## **OPERATING WHILE INTOXICATED**

Officers were dispatched to a report of an intoxicated individual striking parked vehicles while attempting to park a vehicle in the 800 Block of Hawthorne Avenue on April 21<sup>st</sup>. Upon arrival, officers made contact with a 48 year old South Milwaukee woman who showed signs of impairment. Surveillance video showed the woman strike two parked vehicles while attempting to parallel park. She was arrested and referred to the Milwaukee County District Attorney's Office on a charge of Operating While Intoxicated-4<sup>th</sup> Offense.
