

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 7/8/19 – 7/14/19



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **324** calls for service.

DISORDERLY CONDUCT

Officers were dispatched to a report of two individuals creating a disturbance at a residence in the 800 Block of Madison Avenue on July 11th. Upon arrival, officers located a 34-year-old South Milwaukee man and a 24-year-old South Milwaukee man involved in an argument with an 18-year-old South Milwaukee man. The 34-year-old man and the 24-year-old man were issued citations for Disorderly Conduct while the 18-year-old man was issued a citation for Battery after it was determined he struck the 24-year-old man with a crutch.

Officers were dispatched to a report of individuals fighting in the 600 Block of Mackinac Avenue on July 9th. The individuals involved, a 30-year-old South Milwaukee woman and a 42-year-old South Milwaukee woman, had been separated from each other prior to the arrival of officers. An investigation determined the 30-year-old woman confronted the 42-year-old woman after she yelled at the 30-year-old woman's children for bothering her dog. Both women were issued citations for Disorderly Conduct.

A 54-year old South Milwaukee man called the police department stating he was detaining two individuals who he observed enter a neighbor's vehicle in the 400 Block of Nicholson Avenue during the overnight hours of July 10th. Officers arrived on scene and found the man detaining a 16-year-old West Allis boy and a 14-year-old Oak Creek boy who he stated had opened the door of a truck parked in the area. The youths claimed the vehicle belonged to a relative but when contacted, the owner of the vehicle did not know either of the boys. There was no damage to the vehicle and nothing was missing. Both youths were arrested and taken to the police station. The 16-year-old boy was issued citations for Disorderly Conduct and Curfew Violation while the 14-year-old boy was issued citations for Disorderly Conduct, Curfew Violation, and Juvenile Possession of Tobacco Products for a vaping device found in his possession. Both boys were released to their mothers.

DAMAGE TO PROPERTY

South Milwaukee Street Department personnel reported an individual continuing to etch his initials in a freshly poured and smoothed concrete sidewalk section in the 1200 Block of Michigan Avenue on July 12th. The subject, a 53-year-old South Milwaukee man, used a stick to damage the fresh concrete and was advised to refrain from the activity once the section was repaired. When he once again damaged the section with the stick, officers were called. He was arrested and taken to the police department where he was issued a citation for Criminal Damage to Property.

RETAIL THEFT

An officer on patrol in the 200 Block of North Chicago Avenue was advised two individuals were leaving a business in the area without paying for multiple items. The officer located the individuals in a parked vehicle and was able to position his squad to prevent them from leaving. The stolen merchandise was located inside the vehicle and the individuals, a 36-year-old Milwaukee man and a 25-year-old Milwaukee woman were arrested and taken to the police station. The man also had a confirmed warrant with the Waukesha County Sheriff's Department. Both were referred to the Milwaukee County District Attorney's Office on Retail Theft charges and the man was taken to the Waukesha County jail on the warrant.
