

SOUTH MILWAUKEE POLICE DEPARTMENT

WEEKLY CRIME SUMMARY 8/5/19 – 8/11/19



(This report does not include every call for service but rather serves as a highlight of notable calls where a report was filed.)

The past week the South Milwaukee Police Department responded to **368** calls for service.

DRUG INVESTIGATION

Officers were dispatched to a report of a parked vehicle in the 2900 Block of South Chicago Avenue occupied by an individual who appeared to be under the influence of a controlled substance on August 5th. Upon arrival officers spoke with a 37-year-old Oak Creek woman who showed signs of impairment. Drug paraphernalia was also located inside the vehicle and the woman was found to be out on bail with a condition being she was not to use controlled substances or possess drug paraphernalia. She was arrested and charged by the Milwaukee County District Attorney's Office with Possession of a Controlled Substance-Narcotic Drugs and Felony Bail Jumping. She was also issued citations for Possession of Drug Paraphernalia.

DISORDERLY CONDUCT

Officers were dispatched to a report of a male not wearing clothes and defecating in the 500 Block of Madison Avenue on August 7th. Officers located a 54-year-old Milwaukee man sitting on the sidewalk with his shorts down and a backpack over his lap. There was fecal matter on the sidewalk next to him. He was arrested and issued a citation for Disorderly Conduct.

A 27-year-old South Milwaukee man reported his tenant causing problems in the 600 Block of Columbia Avenue on August 7th. The man provided a video that showed a 62-year-old South Milwaukee woman shouting profanities at him and his girlfriend. The woman was issued a citation for Disorderly Conduct.

OPERATING WHILE INTOXICATED

An officer observed a vehicle make an illegal U-turn in the 1100 Block of Milwaukee Avenue on August 11th and initiated a traffic stop in the 1000 Block of Milwaukee Avenue. As the vehicle stopped, three individuals exited the vehicle from the passenger side. Officers were able to identify the driver of the vehicle as a 31-year-old South Milwaukee man who showed signs of impairment. He was arrested and charged by the Milwaukee County District Attorney's Office with Operating While Intoxicated-5th Offense. During the course of the investigation one of the passengers refused to identify himself and fled the scene. He was apprehended a short while later and identified as a 35-year-old South Milwaukee man who had confirmed warrants with the Waukesha County and Washington County Sheriff's Departments. He was arrested and charged by the Milwaukee County District Attorney's Office with Resisting/Obstructing and Disorderly Conduct.

A 36-year-old Oak Creek man reported following a suspected impaired driver near College Avenue and Southtowne Drive on August 7th. The man reported a vehicle bumped his car in Milwaukee and he followed the vehicle to South Milwaukee. A second witness also reported the vehicle driving erratically. Officers spoke with the driver of the vehicle, a 20-year-old South Milwaukee woman, who showed signs of impairment. She was arrested and taken to the police station where she was issued a citation for Operating While Intoxicated-First Offense before being released to a sober adult.

A caller reported an individual driving away intoxicated from the 1100 Block of Milwaukee Avenue on August 10th. An officer located the reported vehicle and observed it make an illegal turn at 10th and Milwaukee Avenues. A traffic stop was initiated and the driver, a 28-year-old South Milwaukee man showed signs of impairment. He was arrested and taken to the police station where he was issued a citation for Operating While Intoxicated-First Offense before being released to a sober adult.
